2013 -2014 College Liaison Unit Accomplishments.

- I. College Liaison Unit contributed to a 31 percent reduction in robberies on beat 101, during the fall 2013 semester.
- II. College Liaison Unit contributed to a 17 percent reduction in robberies on beat 101, during the spring 2014 semester.
- III. College Liaison Unit contributed to a 39 percent reduction in robberies on beat 401, during the fall 2013 semester.
- IV. College Liaison Unit contributed to a 15 percent reduction in robberies on beat 401, during the spring 2014 semester.
- V. Overall crime surrounding the college and university campuses, in the AUC, was down 17 percent from 2012 to 2013.
- VI. Partnered with college and university students in the Atlanta University Center to conduct a campus-walk thru, whereby student's observation of lighting outages as well as a need for additional lighting were noted and passed along to the Mayor's Office.
- VII. Established effective collaboration and partnership with SGA representatives from Georgia Tech, Georgia State University, Morehouse College, Spelman College, Emory University, Atlanta Metropolitan College as well as Clark Atlanta University. Our relations with the colleges and universities have not only contributed to events such as domestic violence and sexual assault forums, drug awareness seminars, sex trafficking events and public safety meetings; but has also contributed to APD's ability to gather intelligence reports during sensitive issues affecting college and university students, such as projected reaction of students in the wake of the George Zimmerman verdict.
- VIII. Worked with Atlanta Police Department's Crime Stoppers Unit, to provide college and university campuses information and handouts on the crime stoppers program.
- IX. Worked with the Atlanta Police Department's narcotics unit and FIT teams, whereby College Liaison Unit provided information on drug houses and suspects surrounding the college and university campuses. In one instance, we were able to provide information

into a school councilor distributing narcotics on the college and university campuses. Several drug related arrests of locals surrounding the campuses as well as students.

- X. Established relations with the Student Safety Advisory Group, a group of student representatives sworn-in by the Mayor's Office to offer suggestions on improving safety surrounding college and university campuses.
- XI. Submitted plans of action on major events taking place on the college and university campuses consisting of, but not limited to, Morehouse and Clark Atlanta University athletic games, the funeral services of Rev. Joseph E. Lowery's wife Evelyn Lowery, Atlanta University Center Homecoming as well as undercover operations taking place on and surrounding the campuses.
- XII. Coordinated and taught Crime Prevention through Environmental Design (CPTED) training for college and university students as well as law enforcement officers.
- XIII. Analyzed robbery data and crime statistics impacting the college and university campuses to disseminate useful information to campus law enforcement officers, such as look-out descriptions on perpetrators and vehicles.
- XIV. Partnered with college campus law enforcement officers to deliver mandatory safety presentations which provide students with student victimization case studies, crime prevention tips as provided by the National Crime Prevention Council, anonymous reporting information as well as crime statistics in the areas surrounding the campuses.
- XV. Successfully collaborated with the zone's criminal investigations divisions to apprehend robbery perpetrators, who sought students as their victims.
- XVI. Coordinated and taught The Law and You roughly 20 times on college and university campuses throughout the City of Atlanta
- XVII. Established and working closely with AUC NEXT STEP, a program comprised of college and university students who conduct open discussions with Atlanta's at-risk youth and gang members.
- XVIII. Conducted undercover drug operations surrounding college and university campuses to apprehend perpetrators distributing narcotics on and surrounding college campuses.

College Liaison Unit Fall 2013 RECAP/ Spring 2014 Objectives.

My unit has set three goals for Spring 2014 of which we believe will maximize our ability to make a continued impact on crime in the surrounding area of the Atlanta University Center.

- Improve/ streamline communications with Atlanta University Center Police Agencies
- Deploy field Investigations efforts surrounding the AUC to increase narcotics as well as quality of life related arrest
- Continue student engagement in an effort to provide an opportunity for open dialogue as well as student involvement within the local community

Our first goal will be accomplished by establishing opportunities for collaborative "information sharing briefings", whereby each agency is encouraged to send one officer representative to carry information back to their respective agencies. At these briefings, the APD College Liaison Unit will provide information on recent look-out descriptions, suspect vehicles, officer safety alerts provided by homeland security and recent developments that impact the safety of AUC students. We are suggesting the joint briefings be held once a week on Thursday @ 6pm, alternating meeting locations between each school. In addition, we're asking that an email signup sheet at each of your precincts be provided for officers who wish to be included in email updates on information concerning the AUC target area. It is important to note, we noticed an exceptional reduction in crime during the two weeks all AUC agencies conducted a joint roll call informational. As a result of all agencies sharing information we were able to target problems and suppress crime. This fact is supported by crime statistics provided 12/4 thru 12/16.

Moreover, the field investigations will be deployed by my unit directly within the AUC target area, which will cut out the previous delay in response from narcotics units and field investigations teams. These units are extremely limited in manpower and overloaded with complaints and dealing with problems throughout the entire City of Atlanta; therefore, it makes it virtually impossible for them to expeditiously respond to our request consistently throughout the semester. We will lead the investigations as we have already begun with an undercover drug buy within the target area last night, resulting in the arrest a senior at Clark Atlanta University. The student provided information pertaining to robberies which occurred last semester and further advised of narcotics related activity currently in progress within the target area. A tactical plan and HIDTA deconfliction number has been obtained to resolve immediately.

Lastly, it is important that we continue to foster healthy relationships with our valued stakeholders in the community, including businesses, students, and citizens of the City of Atlanta residing within the AUC target area. We will continue to respond to request to attend sexual assault/ domestic violence panels, crime prevention forums as well as plugging the students of the AUC into service opportunities with the Atlanta Youth Initiative Project, a project of which an organization entitled AUCNextStep has already made a great impact by working with juvenile gang members and at-risk youth. We have a calendar of events for Spring 2014 and are happy to share if any officers in the AUC are interested in attending.

Looking forward to a safe and productive semester. Weekly emails and crime stat alerts will resume on Friday, January 16th. Thanks and have a great weekend.

- College Liaison Unit apprehended subject Zakee Lewis (DOB 6/18/1996), on warrants for Theft By Taking and Criminal Damage to Property (Beat 401).
- Obtained HIDTA deconfliction on two houses allegedly selling narcotics within AUC target area. After receiving a narcotics tip on one of the two houses, the unit conducted surveillance, and subsequently apprehended a subject of whom we recovered narcotics from his person. The investigation is ongoing; however, we have confirmed that members of the blood gang are operating out of one of the two houses currently under investigation. Statements received from an arrestee have been corroborated by NCIC/GCIC inquiries obtained while making contact with an individual traveling from the home. Gangs unit has been notified.
- Conducted directed patrols on the streets surrounding and intersecting the AUC campuses. Specifically patrolled Westend Ave @ Westview Drive, Joseph E. Lowery @ Sells Ave (Chevron gas station), Joseph E. Lowery @ Westend Ave, Paschals @ Drummond, Paschals @ Mitchell Street, Bonair @ Beckwith, Beckwith @ Ozone, Parsons @ Ozone, Parsons @ Bonair, Parsons @ Euhurlee, Parsons @ Webster, Northside Drive @ Greensferry Rd, Lee St @ Ralph David Abernathy. Also, conducted traffic-stops as well as suspicious person stops surrounding campus.
- Attended the Atlanta University Center Neighborhood Association meeting on 1/16/2014, whereby we outlined the units goals for the Spring 2014 semester. Members of the association posed questions pertaining to cameras being placed in the area, where to obtain crime statistics, engaging homeowners who continue to rent homes to non-students on Parsons St and Joseph E. Lowery as well as requested information on efforts currently underway to reduce crime.
- Met with Crime Analysis Unit, Officer Sime', who provided a 2012 to 2013 crime comparison, at request of Chief Johnson (Morehouse College). Overall crime surrounding the AUC showing to be down 17% while pedestrian robberies are down 19%. Crime Statistics showing a 51% decrease in thefts from auto.
- Met with AUCNextStep on 1/16/2014, for first official meeting of the semester. The students will be participating with the Atlanta Youth Initiative Project this semester at Forest Hills Academy, an alternative school within the Atlanta Public School System. Students will be transported for service hours every Wednesday throughout the semester to teach course content under "The Law and You" curriculum.

- College Liaison Unit met w/ Investigator Joyner (US Marshals Taskforce) in reference to whereabouts of Jatarvis Cooper, who is currently residing within the AUC target area. A City of Atlanta approved confidential source, registered to the College Liaison Unit, confirmed the whereabouts of the subject.
- On 2/6/2014 College Liaison Unit Officers acted in an undercover capacity within the AUC target area, utilizing confidential sources and City of Atlanta confidential funds, to purchase illegal narcotics from a residence whereby confirmed drug and gang activity is taking place. CLU will be partnering with SWAT to execute warrant on location.
- College Liaison Unit continued partnership and collaboration with the Atlanta Police Department's Narcotics Unit on 2/2/2014, making contact with Investigator Burkes in reference to narcotics activity taking place at a residence within the AUC target area. Investigation was turned over to Investigator Burkes as a result of the geographical location of the premise. Narcotics Investigators were provided with a typed transcript and video recording pertaining to the residence. Subsequently, a follow-up with narcotics investigators confirmed illegal drug activity taking place at the location.

On 2/24/2014 The Atlanta Police Department's College Liaison Unit executed a search warrant at the location of 118 Joseph E. Lowery SW, Atlanta Ga 30314, bringing an end to an undercover investigation ranging over the course of a two month time period, starting on December 28th with undercover drug purchases from KING, VANESSA. Affiliated members of the blood gang were apprehended, approximately 3.4 grams of MDMA/ecstasy, as well as approximately 7 ounces of marijuana were recovered from the location. At the time of the warrant entry, 16 individuals were detained inside and/or attempting to flee from the residence upon entry. A total of 5 arrest were made. This operation was conducted in conjunction with the US Marshals Fugitive Taskforce and the Atlanta Police Narcotics Unit (Team 5). Also, Morehouse Police Department was contacted and provided perimeter support during the execution of the search warrant. College Liaison Unit will be working closely with Zone 1 CID to determine if any of the detained individuals are connected to student robberies occurring this semester and last semester, as we have received extensive information tying the drug house to robberies.

- On Saturday (03/1/2014) in response to multiple complaints/concerns from the citizens of the Ashview Heights Community, the Atlanta Police Department led a "Community Tack Back" walk through in collaboration with Citizens of the Ashview Heights Community, Morehouse College Police, Georgia Power Revenue Protection, Fulton County Animal Control, and City of Atlanta Code Enforcement.
 - As a result of the "Community Take Back" walk through, a list of essentially 85 dilapidated, abandoned, and/or vacant houses surrounding the Atlanta University Center, specifically in the Ashview Heights Community was compiled.
 - 1026 Ashby Grove, a residence suspected of being used for the use and sale of illegal narcotics was targeted during the walk through as it was additionally suspected of stealing power and water from the City of Atlanta/Georgia Power.
 - Two individuals were arrested for stealing power as well as occupying the property (1026 Ashby Grove) without authorization.
 - Two pit bulls were turned over to Fulton County Animal Control for health/psychological evaluation and hopefully eventual adoption.
 - A child was located on the property of 1026 Ashby Grove and the Department of Family and Children Services (DFACS) was notified of a child living under extremely inhumane conditions.
 - There were four separate case numbers generated from the residence at 1026 Ashby Grove, whereby four separate apartments were placarded. Subsequently, we notified the owner of the property who will be cited for a variety of code violations. This property has been registered with the City of Atlanta as a Placarded property forbidding its occupancy at this time.
 - Several other vacant apartments and homes in the area were cleared for safety, whereby Georgia Power Revenue Protection Agents observed, documented and cited individuals for theft of power.

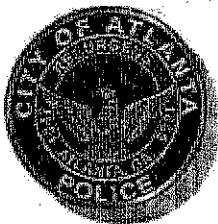

Objective:

To support the Atlanta University Center in reducing crime, as well as contributing to the students safe departure at the end of spring 2014 semester. Particularly, this objective is critical during the times consisting of May 8 – May 25, also known as the "Commencement Period", whereby the colleges report an increase in crime and need for enhanced patrols. There will be a large number of students leaving the Atlanta University Center to begin summer vacation.

Mission:

To reduce crime on beats 101 and 401 by utilizing additional patrols responsible for identifying state law and city ordinance violations immediately surrounding the college and university campuses.

Goals:

- Reduce Part I and Part II crimes on beat 101 and 401 throughout the commencement period, with a concentrated effort between the dates of May 8 – May 25.

Operational Plan:

May 8 – May 25, the College Liaison Unit will partner with Zone 1 and Zone 4 Officers from the Community Liaison Unit, whereby hours will be augmented from 1500 to 2300 hours, as AUC Public Safety Management has reported these to be critical hours for students moving off campus. Officers will be on lookout for suspect vehicles in addition to making traffic and suspicious person stops in the area. The college and university campuses also report an increase in crime during the final weeks of school; therefore officers will be on the lookout for individuals targeting students to commit crimes.

Officers participating in the enforcement detail during these dates will brief at 1530 hours at the location of 830 Westview Drive, in front of the Morehouse College mini precinct. I am

respectfully requesting one Atlanta Police Department supervisor accompany us during the detail.

In addition, I am requesting the tactical traffic unit commit at least one hour of enforcement on beats 101 and 401 throughout the specified time frame of the detail.

The target area within the beat locations consists of Ralph David Abernathy, Lee St as well as "The Box" consisting of Northside Drive, Westend Ave, Joseph E. Lowery and Martin Luther King Jr. Drive. Officer will focus their efforts along and inside of the specified areas.

Beats Location:

- Zone 4- Beat 401 and Zone 1; Beat 101

Plan of Action Time Frame:

Thursday 5/08/2014 thru Sunday 5/25/2014 during evening watch hours.

Expected Results

- We will reduce crime by 10% for the Cobra Week encompassing the plan of action time frame.
- Establish ongoing collaboration and partnership with Atlanta University Center Police Departments. RE: Narcotics Enforcement Detail Surrounding Atlanta University Center

Objective:

To support the college and university campus police agencies in reducing narcotics sells, which have been responsible for violent crime, on and surrounding campus.

Mission:

Utilizing a community response team, the mission is to reduce crime on beat 101, which encompasses the Atlanta University Center (AUC), by taking direct and immediate action to investigate houses and individuals responsible for the sell of narcotics on and surrounding the college and university campuses. In addition, this plan of action consists of continued enforcement of city ordinances as well as state laws within the target area.

Goals:

- Reduce Part I and Part II crimes on beat 101 throughout semester II (18 weeks ranging from 1/6/2014 to 5/9/2014.
- Specifically, we will conduct the detail 1/6/2014 through 5/9/2014 in partnership and continued collaboration with Atlanta University Center police agencies.

Operational Plan:

During the operational period, the College Liaison Unit, along with officers Russell and Barton of the Community Liaison Unit, will operate in collaboration with Atlanta University Center police agencies to investigate and apprehend individuals in violation of the Georgia Controlled Substance Act on and surrounding the AUC. Currently, three houses are under investigation/ deconfliction, whereby credible and reliable sources point to narcotics activity operating out of the homes. All three houses are immediately surrounding the Atlanta University Center. All three homes have been photographed and evidence has been documented in conjunction with Assistant Chief Smith (Morehouse College Police Department). One of the homes falls outside of the 500ft jurisdictional boundary provided to

campus law enforcement and therefore; the Atlanta Police Department will be leading the investigation.

Officers R. Woolfolk and J. Graham, both certified Field Investigations Trained Officers, will be leading the investigations. A tactical plan will be submitted for **each** investigative plain clothes operation/detail. Officers will need access to an undercover vehicle on occasion. The officer's investigative efforts which lead to obtaining a search warrant will be turned over to the Atlanta Police Departments Special Weapons and Tactics Team (SWAT).

Officers Barton and Russell will be assisting the FIT officers with close area cover, transport, mark patrol car take-down response, as well as the enforcement of city ordinance and state laws during crime enforcement details in partnership with AUC police agencies.

Moreover, the officers including College Liaison Unit, CLU Officers Barton and Russell along with specified AUC police officers will be acting together as a community response team throughout the second semester. This will consist of officers continuing to attend community meetings, continued engagement and interaction with students regarding crime, trainings, forums, and service opportunities, while also carrying out the operational goals as listed in this action plan. The team will keep supervision updated weekly in the form of a "Weekly Activity Report".

Beats Location:

- Zone 1- Beat 101, 102, 104, 401 (corridor of Lee St whereby students utilize the sidewalks leading to the WestEnd Train Station).

Plan of Action Time Frame:

1/6/2014 to 5/9/2014 during hours necessary and required to accomplish the outlined operational goal.

Expected Results

We will reduce crime by an estimated 30%. This estimation has been made by utilizing a 2012 to 2013 first semester crime comparison of the College Liaison Units impact on 101's beat.

Establish ongoing collaboration and partnership with Atlanta University Center police agencies as well as Zone 1 for the purpose of reducing crime surrounding the college and university campuses on beat 101.

Officers participating in the enforcement detail during these dates will brief at 1830 hours at the location of 830 Westview Drive, in front of the Morehouse College Police Department. I am respectfully requesting one Atlanta Police Department supervisor accompany us during the detail.

Beats Location:

- Zone 4- Beat 401 and Zone 1; Beat 101

Plan of Action Time Frame:

Thursday 12/05/2013 and Saturday 12/14/2013 during evening watch hours.

Expected Results

We will reduce crime by 10% for the Cobra Week encompassing the plan of action time frame.
