- Identify opportunities to market Xpress to potential new riders










Implementation of Horizon 1


Horizon 1 implementation – Board steps to adoption

- Draft service changes and fare recommendations presented today
- 2. Public comment period open March 21-April 19
- 3. Public hearings scheduled for March 29 and 31
- 4. Board adoption of final service and fare recommendations (May)
- 5. Marketing and outreach activities continue
- 6. Horizon 1 service changes launch September 6, 2016




Horizon 1 Service Changes – GA 400 Corridor

- 400 Schedule/stop location changes between Cumming and Downtown/Midtown. Reverse commute discontinued.
- New 401 Provides new service between Cumming and Perimeter
- 408 Schedule and bus stop location changes between Johns Creek and Doraville Station via Peachtree Parkway



Horizon 1 Service Changes – I-85 North


- 410 Schedule/stop location changes between Sugarloaf Mills and Lindbergh Center.
- 411 Schedule/stop location changes between Hamilton Mill/Mall of GA and Midtown. Reverse commute discontinued.
- 412 Schedule/stop location changes between Sugarloaf Mills and Midtown. Reverse commute discontinued.
- 413 Schedule/stop location changes between Hamilton Mill/Mall of GA and Downtown. Reverse commute discontinued.
- New 414 Consolidates trips during peak "shoulders" between all I-85 North Park & Rides and Midtown (Routes 411, 412, 413)
- 416 Schedule/stop location changes between Dacula and Downtown/Midtown. Reverse commute discontinued.
- New 417* Provides new service between Sugarloaf Mills and Perimeter.





Horizon 1 Service Changes – US 78 and I-20 East


- New 419 Consolidates service between Snellville/Stone Mountain and Downtown (Routes 418 and 424).
- 423 Consolidates service between Conyers/Panola and Midtown (Routes 421 and 423). Reverse commute.
 Reverse commute discontinued.
- New 426 Consolidates service between Conyers/Panola and Downtown (Routes 420, 422, and 425).
 Reverse commute discontinued.
- 428 Schedule/stop location changes between West Conyers/Panola and Perimeter.






Horizon 1 Service Changes – I-75 South

- 430 Schedule/stop location changes between McDonough and Downtown. Reverse commute discontinued.
- 431 Schedule/stop location changes between Stockbridge and Midtown. Reverse commute discontinued.
- 432 Schedule/stop location changes between Stockbridge and Downtown. Reverse commute discontinued.
- 440 Schedule/stop location changes between Hampton/Jonesboro and Downtown/Midtown (Consolidate/ coordinate with Route 441)
- 441 Schedule/stop location changes between Jonesboro and Downtown/Midtown. Reverse commute discontinued.
- 442 Schedule/stop location changes between Riverdale and Downtown. Reverse commute discontinued.



Horizon 1 Service Changes – I-85 South

 New 453 – Consolidates service between Newnan/Union City and Downtown/Midtown (Routes 450, 451, and 455). Reverse commute discontinued.



Horizon 1 Service Changes – I-20 West

- New 463 Consolidates service between Douglasville and Downtown/Midtown (Routes 460, 461 and 462). Reverse commute discontinued.
- 475 Discontinued service between Mableton and Downtown.
- New 476 Consolidates service between Hiram/Powder Springs and Downtown/Midtown (Routes 470 and 477). Reverse commute discontinued.





Horizon 1 Service Changes – I-75 North

- 480 Schedule and bus stop location changes between Acworth/Town
 Center and Downtown.
- New 482* Provides new service between Town Center and Perimeter
- New 483 Consolidates service between Woodstock/Town Center and Midtown (Routes 481 and 491).
 Reverse commute discontinued.
- 490 Schedule and bus stop location changes between Canton/Woodstock and Downtown.





Horizon 1 Service Changes – Midtown

- Common service pattern for all routes where practical and feasible.
- Stops placed approximately every two blocks as needed near major employment centers.
 - Ongoing coordination with local jurisdictions.
- Maintains partner connections (MARTA / GCT / CCT) at Civic Center, North Avenue, Midtown and Arts Center MARTA Stations.



Horizon 1 Service Changes – Downtown








Horizon 1 Service Changes – Perimeter

- Common service pattern for all routes where practical and feasible.
- Stops placed approximately every two blocks as needed near major employment centers.
 - Ongoing coordination with local jurisdictions.
- Maintains partner connections (MARTA) at Sandy Springs, Dunwoody and Medical Center MARTA Stations.







Fare Consistency – Future Goals

- Move to a system wide flat fare
- Streamline fare products
- Streamline fare media



Transit service and fare equity analysis (Title VI)

- Proposed fare changes and service changes will be analyzed for disproportionate impacts.
- Analysis will determine and quantify benefits to and potential negative impacts on minority and low-income populations.
- If disproportionate impacts are identified, they must be avoided, minimized, or mitigated.
- Final service plan and fare recommendations will address Title VI requirements.



Measuring and managing success

- Performance forecasts will be used to determine what is working and what isn't. Focus on:
 - Productivity boardings by route
 - Efficiency average passenger trip loads
 - Reliability on-time performance
 - Customer Satisfaction customer satisfaction survey results
- Proposed targets will be presented at May board meeting.

Xpress will carry more riders!



Horizon 1 marketing and outreach activities

- Public meetings March 29 and 31
- Website redesign
- Campaign to highlight: improved service, new Wi-Fi, "Find My Bus" app
- New materials highlighting bus stop changes, routes and schedules
- Engagement of partner advocates (CIDs/TMAs)
- In-person events and social media activities to promote and prepare for launch

- Finalize service plan and fare changes based on feedback
- Calculate baseline performance metrics and set targets
- Present results at May board meeting
- Adopt changes at May board meeting
