

**AN ORDINANCE BY FINANCE/EXECUTIVE COMMITTEE AMENDING CHAPTER 110, ARTICLE I, SECTION 110-3 FEE SCHEDULE OF THE CITY OF ATLANTA CODE OF ORDINANCES TO INCREASE CERTAIN FEES RELATED TO AMENITIES AND PROGRAMS OFFERED AT THE CHASTAIN ARTS CENTER AND GALLERY BY THE OFFICE OF CULTURAL AFFAIRS; AND TO DIRECT THAT THE REVENUE FROM THE FEES BE DEPOSITED INTO THE ACCOUNTS SET FORTH HEREIN; AND FOR OTHER PURPOSES.  
(HELD ON 5/10/17 FOR PUBLIC HEARING)**

WHEREAS, Chapter 110, Article I, of the City of Atlanta (“City”) Code of Ordinances, Section 110-3 (“Fee Schedule”) establishes fees structure for individuals and groups wishing to utilize City amenities and participate in City programs, including classes, and activities, offered by the Office of Cultural Affairs at the Chastain Arts Center and Gallery; and

WHEREAS, the cost of operating and providing various amenities and programs at the Chastain Arts Center and Gallery has increased due to personnel and programing needs; and

WHEREAS, the City wishes to amend the Fee Schedule to increase and add certain fees for the purpose of supporting programming at the Chastain Arts Center and Gallery.

THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY ORDAINS, as follows:

SECTION 1: That Chapter 110, Article I, of the City of Atlanta Code of Ordinances, Section 110-3 (b)(1) titled “Chastain Arts Center and Gallery” is hereby amended to read as follows (with permanent additions in bold font and permanent deletions in strikethrough font):

Sec. 110-3. - Fee schedule.

(b) The following fees shall be charged for participants in certain Cultural Affairs programs and admission to certain Cultural Affairs venues:

Room Rental:

Fee-based workshops, and meetings-20% of revenue or minimum of ~~\$25.00~~ per hour (whichever is greater).\$30.00 per hour

Art organizations and individual artists ..... ~~\$7.00~~9.00

Social and special events-~~\$75.00~~ per hour (4-hour minimum); ~~\$100.00~~ per hour per additional hour; Additional ~~\$50.00~~ per hour for all off hour rentals

Fees are \$300 minimum for first four hours, \$75 each additional hour. Off hours rental fee is \$500 minimum for first four hours, plus \$150/additional hour

Refundable cleaning deposit ..... ~~\$150.00~~100.00

Gallery Fees:

~~Entry Fees for juried exhibits Not to exceed \$25.00 per entry.~~

Commissions on sales of art-Not to exceed 35% of total cost.

Miscellaneous Fees:

Non-resident fee-~~\$10.00~~ per session (Age 65+ exempt, Summer Camp students exempt)

Material Fee-Not to exceed ~~\$30.00~~ per class. 35.00
