

**A RESOLUTION BY COUNCILMEMBER JENNIFER N. IDE AS SUBSTITUTED BY FINANCE/EXECUTIVE COMMITTEE REQUESTING THAT THE MAYOR TAKES INTO CONSIDERATION AND FUNDS PRIORITIES THAT THE ATLANTA CITY COUNCIL RECOMMENDS BEING INCLUDED IN THE FY 2021 BUDGET; AND FOR OTHER PURPOSES.**

WHEREAS, Section 6-302 of the Atlanta City Charter provides authorization to the Mayor to prepare and submit the proposed Annual Budget Ordinance to the governing body; and

WHEREAS, Ordinance 05-O-1976, adopted by the City Council on November 21, 2005, further provides that the Atlanta City Council will submit via resolution its priorities to the Mayor for consideration in the preparations of the Tentative Budget for the upcoming year.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, that the Atlanta City Council submits to the Mayor for consideration and inclusions in the FY 2021 Budget, the priorities listed:

Fiscal Stability

- That the FY 2021 Budget be structurally balanced.
- Full rollback of the millage rate.
- Aggressively pursue grant opportunities.
- Expenditures for one-time expenses shall be derived only from one-time revenues.
- Recurring expenses shall not be anticipated from reserve funds.

Community Development

- \$500K allocated to Community Loan Fund within budget for Invest Atlanta
- \$500K for Emergency Housing Stabilization Fund to incorporate any council districts with high concentration of renters in low AMI areas.

Personnel


- Ensure gender pay equity.
- Continue public safety pay raises.
- Fully fund Ethics, Audit, Compliance, Inspector General and Transparency functions.
